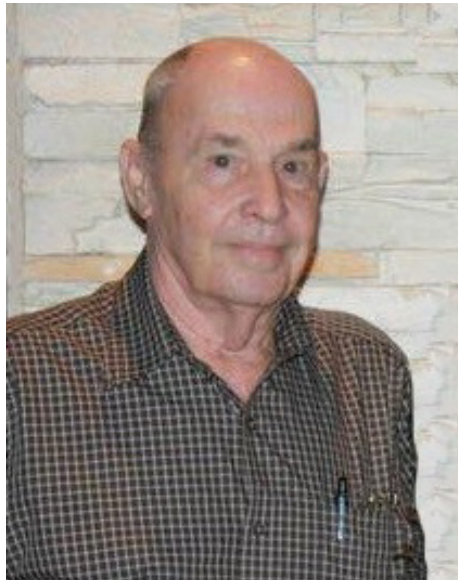

TMSCA says goodbye to pioneer

Behind every great organization, there are usually two people. One is the person who is the face and voice of the organization. The other is the "silent partner" - the one you never see.

For 30 years, Jo Kesner was the Executive Secretary of TMSCA - the face and voice of TMSCA. Unknown to a lot of TMSCA coaches, there was another person who stayed in the background and worked diligently to move TMSCA forward into the computer era. His name was Jerry Kesner, Jo's husband, affectionately known as "Pop."

Jerry became involved in TMSCA after he retired from Sun Pipe Line. Having witnessed TMSCA coaches crawling around on the floor sorting papers and compiling scores at state meets by

hand, he figured there had to be a better way to accomplish this feat. In his spare time, he taught himself DBase and proceeded to develop a computer program to compile results for the state

meets.

But his efforts did not stop there. He further developed the program to track test pool sales, tournament test sales, memberships, state meet entry fees and the general bookkeeping aspects of TMSCA.

Ever present at the state meets, Jerry worked long and hard to keep the TMSCA program running and ever-evolving to meet the needs of TMSCA. He was the "little old man" in the Tab Room at every state meet who responded to every crisis with his gruff chuckle and a quick resolution of the problem to ensure the success of the meet. He was the "silent partner" of TMSCA.

In 2012, Jo Kesner retired from TMSCA, taking with her "her

Policy change Board mandates current membership BEFORE Qualifier participation

The TMSCA Executive Board adopted a policy at the 6/10/17 Board meeting that mandates that all middle schools participating in any TMSCA qualifying meets, whether individual or regional, have a current TMSCA membership in order to be able to register for the meet.

This clarification of policy has been the intent of TMSCA since the original inception of the middle school qualifiers. For the most part, schools have followed this intent in

years past. However, there has been a growing trend for schools to wait and see if any students qualify for state before renewing their membership.

This creates an unusual hardship on the TMSCA state office as those schools then expect their late membership renewals to be expedited so that they can get their students registered for the middle school state meet at the busiest time of the TMSCA year. Qualifying host sites will be furnished a list of current memberships at the

time of their meets. If your school is not on that list, you will not be allowed to participate in the qualifying meet.

PLEASE DO NOT WAIT UNTIL THE LAST MINUTE TO RENEW YOUR MEMBERSHIP. Prior year memberships, if not renewed, become inactive on 12/1/17. If you have already submitted your membership renewal at this time, you should have your new membership card by 12/1/17.

Board proposes amendments to constitution

The TMSCA Executive Board proposed the following amendments to the TMSCA Constitution at its 6/10/17 Executive Board meeting.

Both proposed amendments deal with bringing the time frame of Board members' terms in line with the timing of the summer Executive Board meetings. These changes will allow newly elected Board members to more actively participate in the making of Board decisions affecting the upcoming year.

These proposed amendments will be posted on the TMSCA website and will be contained in the September edition of the TMSCA newspaper, per TMSCA policy. TMSCA members will vote on these amendments at the 2018 TMSCA Business Meetings, held the Friday before each of the high school and middle school state meets. If approved, they will be in effect for the 2018 summer Board meeting.

Here are the proposed amendments. Proposed changes are underlined and in red. All proposed changes are to change the time frame of Board member terms from a starting date of "July 1" to "June 1." The proposed amendments also contain

wording clarifications approved by the Executive Board on 6/10/17.

ARTICLE IV: LEGISLATIVE BODY

Section 5: The term of the President and President-Elect shall start June 1 and last for a period of one year. Term of office for Recording Secretary and Treasurer will start June 1 for a staggered term of two years. The Recording Secretary will be elected in even-numbered years and the Treasurer in odd-numbered years.

The President-Elect will assume the duties of the President after the term as President-Elect ends. The officers shall be nominated and elected by the voting membership at large according to Article IV, Sections 6 and 7 of the TMSCA Constitution. The duties of the elected officers shall be determined by the Executive Board and will be stated in the TMSCA Bylaws.

ARTICLE IV: LEGISLATIVE BODY

Section 7: The Recording Secretary is the chairperson of the Nomination-Election Committee. The chairperson will select committee members or serve as the sole member of the committee. The committee, utiliz-

ing the TMSCA office, will be responsible for issuing ballots to the voting membership within ten (10) days of the close of the nominations period unless all positions are unopposed. In the event that all positions are unopposed, the Nomination-Election Chairman shall declare the nominees elected.

A school membership is entitled to one (1) vote. Ballots must be received in the TMSCA office by the date specified on the ballot. If no candidate receives more than fifty (50) percent of the votes for a particular office, then a runoff election will be held for the two candidates having the top percentages of the vote. In the event of a runoff, runoff ballots must be received by the TMSCA office within ten (10) days of issuance.

The Executive Director will be in charge of informing the outgoing President, the newly elected legislative body and the unsuccessful candidates of the election results. Complete and final results will be published in the next TMSCA newspaper and posted on the TMSCA website. The newly elected legislative body members' terms shall begin June 1.

TMSCA Board moves to promote elementary participation

Special package deal for membership/practice materials offered

After adding elementary materials to the TMSCA test pools over the past four years, the TMSCA Executive Board decided to further promote the participation of elementary schools in TMSCA competitions with two new initiatives for the 2017-18 school year.

This year, for the first time, TMSCA will offer two online meets specifically targeting students in grades 3-5. These meets will be the first TMSCA on-line meets for grades 3-5 that utilize tests written specifically for 3rd, 4th and 5th graders. Previously, 4th and 5th graders were allowed to participate in the

middle school online meets but were actually testing using middle school tests, written for 6th-8th graders.

There will be two meets, one in the fall and one in the spring. Registration for the fall on-line meet will be 11/1/17 through 11/22/17. Testing window will be 11/15/17 through 12/11/17. Results will be posted 12/14/17. Registration for the spring on-line meet will be 3/19/18 through 4/6/18. Testing window will be 4/2/18 through 4/24/18. Results will be posted 4/26/18.

Cost for each meet will be \$50 per school for unlimited students/unlimited contests. A current TMSCA membership is required for participation. Registration is through the TMSCA registration website: www.tmsca.org/

application.

Also, in an effort to boost elementary school membership, TMSCA will offer a special package deal for membership/elementary practice materials. For the special price of \$75, elementary schools may purchase a school membership (\$50) and the 17-18 Elementary Practice materials package (\$50). This represents a savings of \$25 for the package deal. The elementary materials packages feature five each of number sense, calculator, mathematics and science tests written especially for grades 3-5.

The elementary materials packages also make great learning tools for beginners at both the middle and high school levels, especially for the number sense and calculator contests.

TMSCA Executive Board meets in June

Call to order: The meeting was called to order at 7:58 a.m. by President Steve Holmes

Members present: Steve Holmes, president; Sheri Woodall, treasurer; Kendra Bates, secretary; Josh Newton, high school director/president-elect; Cliff McCurdy, UIL liaison; Joan Naylor, middle school director/state meets director; Frances Renfro, book-keeper; Julie Majewski-Smith, executive director. New members: Wenzen Chuang, high school director; Sammy Wyatt, middle school director

High School Director Report - All the coaches preferred not using the Chatsworth cards at the state meet. Josh Newton, high school director, recommended we continue to do this next year.

Middle School Director Report - Joan Naylor, as last year's middle school director, reported that overall the middle school meet went well. Congestion in halls and on stairwells between tests was really bad this year, and Joan has a few ideas to address this issue for next year.

Treasurer Report - Sheri Woodall gave the Treasurer's Report and the Board reviewed it.

Executive Director Report -

1. All tests at high school and middle school are now being proofed for errors.

2. Informational reports were presented to the Board. These reports were reviewed and discussed by the board. (Online meet reports, Dallas ISD initiative impact report, T-shirt sales report, membership report, middle school and high school state meet annual analysis/comparison reports, tournament test sales report, and test pool sales report).

3. Upon recommendation, a motion was passed to add two tests to the elementary test pool for use as on-line EL meets.

4. The Board approved offer-

ing an elementary package deal of membership and test pool for \$75 to encourage more elementary participation. The Board also approved offering a negotiated price for a district package of membership/elementary practice materials

State Meets Coordinator Report

- Joan Naylor gave a final summary report of the 2017 State Meet and Championship Meet. For purposes of proctor requirements for the state meets, Joan recommended and the Board approved lowering this number from 8 to 6. She will use an application called "Volunteer Sign Up" to make sure all the proctor spots are filled for each test.

Joan is exploring using some local San Antonio volunteer groups to provide additional volunteers for the state meets.

UIL Liaison Report - Cliff McCurdy informed the board that all the UIL test writers are secured except for a chemistry writer. They will probably start giving third place team awards at UIL state for math and science events. UIL is forming a Science Advisory Committee, and several TMSCA Board members/representatives have applied to be included on this committee.

Action Item: Review test writer salaries for HS Chemistry and HS Physics - Since UIL is now providing solutions for both High School Chemistry and Physics tests in their new test format, the Board voted to adjust TMSCA test writers salaries to include solutions in our test pool.

Action Item: Taking credit card payments from schools - The Board approved purchasing the equipment to accept credit card payments and move toward accepting credit cards with the extra percentage being charged to the school, by the conclusion of the 2017-18 year.

Action Item: Add trophies for 5A

and 6A - 3rd-6th place sweepstakes at the Middle School Championship Meet - The Board approved adding 3rd-6th place sweepstakes trophies at the Middle School Championship meet in divisions 5A and 6A to provide additional recognition to the large number of students/schools in these classifications.

Action Item: Establish a verification policy for state meets

The Board approved a policy to state that verification of scores will be for a period of up to 30 minutes from the time verification sheets have been distributed. If a school representative is not present for this process, a designated person in the grading room will check the scores for data entry accuracy ONLY. They will be designated by the grading room director.

Action Item: Scholarship Amounts

- Scholarship amounts were set at \$1400, \$1200, \$1100, \$1000, \$900 and \$800, regardless of the supporting donations that were available in the past.

Action Item: Policy on board members and employees helping run meets at a school using the TMSCA program

- The Board approved a policy that board members and employees receive a \$100 stipend per day and mileage for meets they help run using the TMSCA program. Board members and employees must receive permission to work these meets.

Action Item: Policy/Guidelines for running invitational meets using the TMSCA program

- The Board adopted a policy stating that after the first year of using the TMSCA program, we will charge the host school \$150 per person, plus expenses, for meet assistance in subsequent years.

Action Item: T-shirt Cost - The Board voted to increase the price of state meet T-shirts to \$17.

Action Item: 2017-2018 Budget -

The Board reviewed the proposed budget for the 2017-2018 year and approved it as discussed.

Action Item: Approve updated Policy Book and By-Laws -

The Policy Book Review Committee has been working on updating the Policy Book and By-Laws. The Board reviewed and approved these updates. The updated Policy Book will be posted online.

Discussion Items:

1. Updates and corrections to the Constitution – An update to Article IV Sections 5 and 7 must be approved by the membership in order to change the official starting term date for Executive Board members to June 1.

2. Red dots on senior papers at state meet – We will look into using either a stamp or red check to designate senior papers for the 2018 HS meet. Fourth grading of senior papers is no longer required. Seniors in 1A-4A may be grouped in testing rooms.

Action Item: Schools must have a current membership before competing in qualifiers –

The Board approved a policy requiring schools to provide proof of TMSCA membership to host schools prior to participating in qualifying meets. Host schools will have an updated membership list available to them for verification.

A synopsis of TMSCA's 4 contests

Number Sense

Number Sense involves a 10-minute, 80-question mental math test covering all high school mathematics courses. Shortcuts need to be developed and practiced in order to compete and finish the test.

Science

This contest challenges students to do a wide range of reading in biology, chemistry and physics, to gain an understanding of the significance of experiments rather than to recall details, to be alert to new discoveries and information in the areas of science, to gain an understanding of the basic principles as well as knowledge of the history and philosophy of science, and to foster a sense of enthusiasm about how science affects our lives.

Calculator Applications

This contest includes calculations involving addition, subtraction, multiplication, division, roots, powers, exponential, logarithms, trigonometric functions and inverse trigonometric functions.
